The Dangerous Dogs Act

The purpose of the Dangerous Dogs Act is to prohibit persons from importing and breeding dangerous dogs, to impose other restrictions in respect of dangerous dogs, to regulate the manner in which dangerous dogs are kept by their owner or keeper, and to make further provision to ensure that such dogs are kept under proper control so as to ensure public safety.

The aforementioned Act was passed in June 2000 and assented in August 2000 (Act No. 32 of 2000); however, this Act was never proclaimed because it was deemed "too draconian." Under the present administration the Act will be proclaimed by the President as coming into force on August 1, 2012 because of the great harm and injury being caused to law-abiding citizens when 'dangerous dogs' are not properly secured and controlled.

According to the Dangerous Dogs Act, 'dangerous dogs' are defined as follows:-

- The Pitbull Terrier or any dog bred from the Pitbull Terrier;
- The Fila Brasileiro or any dog bred from the Fila Brasileiro;
- The Japanese Tosa or any dog bred from the Japanese Tosa.

Nevertheless, the Act is being revisited because several animal welfare organizations disagree with certain provisions within the Dangerous Dogs Act. For further reading on this Act and its provisions please view the following link: <http://www.ttparliament.org>.

In recent years, there have been numerous attacks on citizens by pitbulls and facts have shown that these dogs have escaped and attacked several persons causing severe injuries and in some cases death. Statistics have proven that five people have been killed and at least fourteen persons mauled by pitbull attacks between 1995 and 2002.

In conclusion, the Dangerous Dogs Act of Trinidad and Tobago was formulated to protect citizens from vicious attacks by ferocious and harmful dogs.

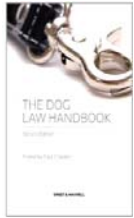
