This Statement must be signed by the individual and when signed must be delivered to the Registrar-General within fourteen days after any change in any of the particulars or within such longer period as the Governor may on application being made in particular, case whether before or after the expiration of such fourteen days allow.

Failure without reasonable excuse to furnish the required statement of any change in the particulars registered within the time specified will, in addition to any disability imposed by the Ordinance, entail liability on conviction to a fine not exceeding Two hundred Dollars (\$200.00) for every day during which the default continues; and any statement which contains any matter which is false in any material particular to the knowledge of any person signing it will entail liability on conviction to imprisonment, with or without hard labour, for a term not exceeding three months, or to a fine not exceeding One Thousand dollars (\$1,000.00), or to both such imprisonment and fine.
